#### **MATTER DETERMINED**

PPSSNH-384 – City of Ryde – LDA2023/0084 at Macquarie University 192 Balaclava Road Macquarie Park – Adaptive reuse of an existing building and construction of a new 6 storey academic building for Physics, Astronomy and Engineering Faculty including refurbishment works (as described in Schedule 1).

### PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings listed at item 8 in Schedule 1.

### **Development application**

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

#### **REASONS FOR THE DECISION**

The Panel determined to approve the application for the reasons outlined below and in Council's Assessment Report.

The application is a Crown Development and has been the subject of extensive consultation between Council and the Applicant since it was lodged in March.

The site currently contains two buildings and the Applicant previously obtained approval for their demolition of the part three/part four-storey building at 7 Wally's Walk and the three-storey building at 9 Wally's Walk.

The Panel notes a Concept Plan for the University was approved in 2009 and it sets the planning regime and development framework for the campus and the Plan includes a campus wide Design Excellence Strategy and Urban Design Guidelines. The Strategy and Guidelines have been updated several times, including in August 2023. The proposed site is Lot A06 within Precinct A of Macquarie University and the proposal is consistent with the objective of Precinct A and is largely consistent with the architectural principles and lot controls for Lot A06 as identified in the Concept Plan.

The Panel concurs with Council that the proposal has been properly assessed against relevant planning controls, is suitable for the site and will provide enhanced educational facilities. Accordingly, the Panel believes approval of the proposal is in the community interest.

## **CONDITIONS**

The Development Application was approved subject to the conditions in Council's Assessment Report.

# CONSIDERATION OF COMMUNITY VIEWS

Coming to its decision, the Panel notes no written submissions were made during public exhibition and therefore no issues of concern were raised.
