S4.55 (6A) MODIFICATION APPLICATION SUBMISSION: CHANGES IN THE DRAWINGS THE LANDMARK QUARTER

Property Address: 4-8 MARSHALL AVENUE, 1-5 CANBERRA AVENUE, 2-8 HOLDSWORTH AVENUE, ST LEONARDS, NSW

As part of our role as structural consulting engineers for the above project, we have reviewed the Architectural drawings for the structural design intent. The architectural drawing register is provided in this statement.

We exercised a standard of skill, care and diligence that would be expected of a professional engineer.

The basic codes used in the design verifications are:

- AS3600: 2018
- AS/NZS 1170.0: 2002
- AS/NZS 1170.1: 2002
- AS/NZS 1170.2: 2021
- AS/NZS 1170.4: 2007
- AS 4100: 2020
- AS 3700: 2018
- NCC 2022.

Our design is also relied on the geotechnical report produced by the Morrow Geotechnics dated 16/02/2022 (Ref – P2160_02) and the subsequent memos (P2160_05, P2160_06, P2160_07, P2160_08, P2160_09, P2160_11, P2160_12 and the email confirmation received from geotechnical engineer 28/05/2024).

The provided shoring drawings certified under CC1, CC1a, CC1b and CC1care not impacted by these changes.

The structural elements within the basement floors can be designed to accommodate the revised basement floor loads and other lateral actions.

This design statement does not relieve the builder or the other consultants from their responsibility to design or construct the Works in accordance with the documentation and accepted building practice, and to comply with relevant laws, regulations, the Australian Standards, and the National Construction Code (NCC).
