## TENTATIVE PANEL DETERMINATION DATE: Within the 275-day timeframe

#### **KEY MATTERS DISCUSSED**

The Panel notes the applicant's presentation and matters discussed with the applicant and council during the briefing. In particular, the Panel notes:

- Submissions from the public, peak architectural bodies and heritage bodies have raised concerns
- Site constraints and viability (to cover the considerable cost of major heritage refurbishment) have shaped the proposal
- Height, bulk, massing, scenic impacts, overshadowing of public domain and heritage impacts are key council concerns.
- The applicant indicated that conflicting heritage advice has been provided from various sources, although Heritage Council advice will take precedence to obtain GTAs.
- A pedestrian movement analysis should be provided to support the access location.
- Council will investigate the impact of potential relocation of bus stops/services on Miller Street

#### **NEXT STEPS**

- Council intend to issue an RFI within the next two weeks
- The Applicant intends to respond to Heritage NSW RFI in next few days
- Mid-May is anticipated RFI response timeframe
- A further full Panel briefing and site inspection is to be held on 25 June

Council is yet to undertake its full application assessment, and therefore future comment will not be limited to matters discussed at the preliminary briefing.
