KEY MATTERS DISCUSSED

The Panel notes the applicant's presentation and matters discussed with the applicant and council during the briefing. In particular, the Panel notes:

- Non-compliance of setback with DCP
- RFI issued 23 May with 21 days to respond
- There is a concurrent stage 1 MOD application (that was court approved). The calculations the Commissioner relied on should be addressed in Council's assessment report.
- The Applicant proposes to consolidate the stage 1 and stage 2 development areas in due course.
- The Panel seek to determine the associated MOD application PPSSNH-637 prior to determination of this DA.
