The Panel considered the matters listed at item 6, the material listed at item 7 and the material presented at the briefing listed at item 8 in Schedule 1.

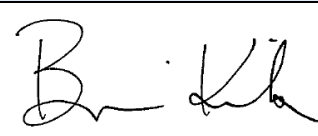
The Panel resolved to defer the determination until 19 August 2026 to allow for the provision of additional information and preparation of conditions of consent.
