# **KEY ISSUES DISCUSSED**

### **Site Visit**

- The applicant provided the Panel with details of the site history, and the current and proposed operation of the quarry.
- Clarification of haulage routes, truck movements and variations to routes dependent on destination of load
- Approved HVNR is in place.
- Site access is limited to Murrays Crossin Road. Ramsay Rd is not used for quarry access by heavy vehicles.
- The applicant currently has in place an "in kind" arrangement to provide royalties to Council to address for road and bridge upgrades.
- Variability of extraction rates, up to 450.000 t/pa dependent on demand.
- Exhaustion of extractive material under current approval.
- Community consultation and exhibition of EIS, noting no submissions received.
- External referrals to EPA and DPE BCD, noting GTAs have not been received to date.
- Blasting frequency every 2-3 months and process of notification to neighbours.

# Planning Panels Secretariat

• Confirmation that there is no night work carried out on site.

### **Council Briefing**

- Council's consultant assessment planner provided a status update of the assessment of the DA and raised the following matters with the Panel:
  - o Changes in output of extractive material.
  - Traffic volume is not a concern, however, consideration to long term maintenance and upgrades due to potential damage attributable to quarry haulage.
  - SVSC does not have a contributions plan.
  - A benchmark or monitoring regime is required to identify potential damage attributable to haulage of product.
  - Haulage route dilapidation reports could be dealt with via a VPA or a dilapidation condition.
  - Council to confirm with applicant that it would be amenable to conditions of consent in this respect as opposed to a VPA.
  - External referrals DPE BCD and flooding.

# **Next Steps**

- Council will prepare an RFI requiring the applicant to provide the following:
  - Survey Plan.
  - Consolidation plan and details of land owners consent (plan illustrating ownership of land parcels).
  - Management of ongoing dilapidation of haulage roads via condition of consent.
  - Biodiversity and flooding issues raised by DPE and any inadequacy of information in supporting reports.
  - End of life rehabilitation (post 25 years) and details as to how principles for future utilisation at end of life can be embedded into conditions of consent.
- The Panel requested the Council finalise the assessment report and bring forward for determination once the FI is received.
