- Adequacy of communal open space in terms of quantum, utility and location on the site
- Geotechnical issues and quantum of cut and fill proposed for sections of the site
- Rural Fire Service comments re:
  - Access to residences
  - Single point access and egress to the site
  - Reticulated water pressure at elevated sections of the site

  - Vegetation clearing on the site
