MATTER DETERMINED

PPSSTH-33 – Wagga Wagga – DA20/0080 at 1 Simmons Street, Wagga Wagga – Change of Use to Educational Establishment (as described in Schedule 1)

PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

DEVELOPMENT APPLICATION

The panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The panel determined to approve the application for the reasons outlined in the council assessment report as well as the following:

- The proposed development is permissible under Wagga Wagga Local Environmental Plan 2010.
- Subject to the recommended conditions of consent as modified in the Council's revised Addendum Report of 1/10/20, the proposed development can operate in conformity with the relevant environmental criteria. In this regard, the panel notes that the updated Ground Doctor Pty Ltd report (1/10/20) related to on-site contamination concluded that the subject site was suitable for the propose land use.
- The Council is satisfied that the applicant has met all the requirements of SEPP 55.
- The panel was satisfied that traffic, parking and acoustic impacts can be properly managed by way of a conditional consent requiring on-site operational management procedures and design noise attenuation measures as recommended in the Noise Impact Statement (JHA).

CONDITIONS

The development application was approved subject to the conditions in the Council assessment report and as modified in the revised Council Addendum Report of 1/10/20.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the panel carefully considered the 3 written submissions made during public exhibition. The panel notes that issues of concern included:

- Loss of parking
- Noise assessment and disturbance
- Remediation Works

The panel considers that concerns raised by the community have been adequately addressed in the original assessment report and the supplementary Addendum report. The panel notes that in addressing these issues relevant mitigation conditions have been imposed to limit the impact of the operations of the Educational Establishment and to preserve the amenity of nearby residents.
