KEY ISSUES DISCUSSED

Council Briefing

• Staging of development.

- Revised Traffic Impact Assessment.
- Outstanding Embodied Emissions Report.
- Flood modelling and mitigation measures for an identified increase in overland flow conditions in relation to surrounding lands.
- Flooding a precondition to the grant of consent Cl 5.22 of Wagga LLEP (significance of flood impacts).
- Council's consultant flood engineer provided a background to the current flood conditions, extent of
 impacts related to the proposed development, modelling principles, and outlined how onsite filling is
 likely to result in ponding onsite resulting in in increased water levels and a reduction in offsite flood
 storage.
- Site isolation principles.
- Previous development history for site.
- Car parking arrangements and consideration of internal arrangements for traffic.
- Internal amenity.
- Rezoning process, noting this was based on the flood information known at the time.
- Surrounding approvals.
- Works on council service road.
- On street parking situation.
- Timing of public exhibition pending flood information.

Applicant Briefing

The applicant provided the Panel with a presentation and the following key matters were discussed;

- Council consideration of internal arrangements for traffic.
- Provision of further information regarding sustainability.
- Management of site isolation through the Master Plan.
- Flooding.

The Panel indicated that urban design outcomes seemed sound and noted Council is currently considering internal arrangements for traffic and vehicular movements.

The Panel encouraged the applicant to continue to work with Council to:

- achieve an acceptable outcome in relation to flooding. The Panel noted that the Council needs to
 be satisfied that the impacts of the flooding are fully and accurately addressed before the
 application proceeds to public exhibition. The Panel encouraged the applicant to clearly
 demonstrate flooding impacts and mitigation.
- Provide further details regarding building sustainability.

The applicant anticipates an outcome on the flooding in the next two (2) weeks and will present a solution to Council that demonstrates the extent of flooding impacts and appropriate mitigation.

The Panel may request a further status update briefing from Council once any further information is provided and the public exhibition process is completed.
