## Purpose of this Memo

This memo updates the Southern Regional Planning Panel (SRPP) on correspondence between Shellharbour Council and the Environment Protection Authority (EPA) with regard to the proposed operating hours of the FOGO Facility at 44 Buckleys Road, through PPSSTH-449 (DAM0118/2024).

Following the SRPP determination meeting on the 18<sup>th</sup> of March 2025, the SRPP recommended Council discuss the following matters directly with the EPA:

- 1. The need for the trial (of extended operating hours) to be embedded into the consent via draft amended condition A7 (noting the EPA have control over the management of the EPL),
- 2. If the trial is required in the consent, the critical timing of the trial period to ensure data is collected over a 12 month period (so as to include summer and winter in the data range, i.e. through a 15-month period instead).

Following discussions between Council and the EPA, the EPA have agreed with shifting the trial out of the consent and into the Environmental Protection Licence 12903. To facilitate this, two key changes have been made in the consent:

- Inclusion of the proposed operating hours within Condition A7,
- Inclusion of EPA correspondence dated 26<sup>th</sup> March 2025 which supports the proposed operating hours, acknowledges that the operating hours in the original GTA's are superseded, and the terms of such a trial period that would be relevant to the EPL.

As such, it is considered that Item 1 has been resolved, and therefore Item 2 is no longer applicable as the trial is not embedded within the consent (such that a further DA modification is not required).

Council understands numerous positions were discussed among the Panel on the wording of Condition A7 to facilitate the terms of Item 1. Council has proposed wording which makes specific reference to the fact that the operating hours within the GTAs have been superseded, and notes the intent to allow the EPA to permit a trial period, or permit the extended operating hours through the EPL at their discretion. Council is supportive of any suggestions to refine this wording as the Panel may decide.

### Summary of Condition Changes

This memo provides an updated 'Attachment A2 – Modified Conditions of Consent' in a word document which includes the changes below.

Changes to the wording of existing conditions are marked red.

### A7 NSW Environmental Protection Authority Modified under DA 523/2014 (Part 3) DAM0118/2024

The development must comply with the General Terms of Approval and advice of the NSW Environmental Protection Authority, as contained in their letter dated 07 May 2015 (Reference: EF15/798, Notice no. 1527988), consisting of seven (7) pages, and as attached to this Notice of Determination.

The recommended conditions of consent, A, B and C on page 6, are to be taken as conditions of this development consent.

This development consent includes the construction of an organics processing facility which will include the receiving, processing, treatment and composting of food waste.

The modifications approved under this consent (Part 2) will require variations made to Environment Protection Licence No.12903 (the Licence) which may include changes to discharge and monitoring requirements. Council will need to submit an application to the Environment Protection Authority to seek approval to vary the Licence.

The modifications approved under this consent (Part 3 – DAM0118/2024) include approval for operating hours as detailed in the table below.

These hours of operation supersede the hours of operation detailed in item 2 of the Environment Protection Authority's General Terms of Approval (Notice No. 1527988, dated 7<sup>th</sup> of May 2015) to the extent of any inconsistencies. However, the EPA may enforce reduced operating hours within the approved operating hours through the Environment Protection Licence 12903, with notification provided to Shellharbour City Council and the site operator. Correspondence has been received from the EPA dated 26<sup>th</sup> of March 2025, reference DOC25/250644 (attached at the bottom of this consent), acknowledging these operating hours supersede the General Terms of Approval, and discussing the terms for a trial period of extended operating hours enforced through the Environment Protection Licence 12903.

**Note:** The intent of modification Part 3 - DAM0118/2024 is to permit extended operating hours, and to allow the EPA to set a trial period for, or permit the extended operating hours at their discretion by varying the Environment Protection Licence number 12903.

1) The premises may operate between the following hours:

- Between 11 April 2025 and 11 April 2026\*, the composting facility may operate with the extended operating hours, as a trial, as detailed below. The trial is subject to the following parameters (a) and b)) being met throughout the trial period:
  - i) Compliance with all conditions of Environment Protection Licence number 12903, including completion of Pollution Reduction Programs; and
  - ii) Good odour performance (no to minimal odour impacts reported by the surrounding community).
