KEY ISSUES DISCUSSED

The following matters were discussed with the council's assessment planners during the briefing:

- The panel is satisfied that the development is not classified as designated development pursuant to Schedule 3 Section 48 of the *Environmental Planning & Assessment Regulation 2021*, as the proposed works involve alterations and additions to the existing boardwalk and the proposed development would not significantly increase the environmental impacts of the existing development.
- The panel advised that it was comfortable that the proposal could be considered under Schedule 3 of Section 48 of the *Environmental Planning & Assessment Regulation 2021* given:
 - o The proposal constitutes alterations and additions to the existing development.
 - The comprehensive nature of the environmental impact assessment undertaken.
 - The predicted minimal environmental impacts.
- However, Council should clearly articulate its justification for the planning pathway in its assessment report to the panel.
- 3 submissions were received during public exhibition, key concerns relate to the safety of a gumtree, narrowness of the existing boardwalk, the need for additional lighting, compliance issues and impact to the Australian Osprey.
- Bikes are not permitted on the boardwalk for pedestrian safety.

- Key issues relate to flora and fauna and the connection of pedestrian networks within Merimbula.
- It was noted that Fisheries had issued their General Terms of Approval (GTAs).

The applicant provided a comprehensive presentation of the site and the proposed works, notably:

- The boardwalk will be constructed using FRP mesh decking.
- The boardwalk will include the reconstruction of two existing jetties and the addition of a new jetty (made of timber).
- Due to storm damage, the boardwalk is currently unusable

Next Steps

• Council will continue to draft an assessment report and conditions for an e-determination scheduled on the 25 June 2025.
