Public meeting held by teleconference on 14 December 2021, opened at 2:30 PM and closed at 3.47pm.

#### MATTER DETERMINED

PPSSTH-69 – Wagga Wagga – DA20/0558 - 190 Rodhams Road, Uranquinty 2652 - Electricity Generating Works (Solar Farm).

#### PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

#### **Development application**

The panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

## **REASONS FOR THE DECISION**

The panel determined to approve the application for the reasons outlined in the council assessment report.

In addition, the Panel was satisfied that:

- The proposed development is permissible with consent and consistent with the objectives of the RU1 Primary Production Zone under *Wagga Wagga Local Environmental Plan 2010*
- The development is appropriately located on the site to minimise visual impact from nearby receptors being dwellings, the adjoining rail line and public roads including the Olympic Highway. Further to this, the Panel was satisfied that, subject to the amended conditions of consent, the visual impact of the development is able to be satisfactorily mitigated by way of vegetation screening.
- The potential for impacts associated with glint and glare is minor and, if identified, is able to be mitigated through a management plan required as a condition of consent.
- The development is able to be managed, operated and decommissioned such that agricultural production on the land can be reinstated at the conclusion of the development.
- The Panel was satisfied that, subject to the conditions of consent, the impacts associated with construction, operation and decommissioning are able to be mitigated or managed.

#### CONDITIONS

The development application was approved subject to the conditions in the council assessment report with the following amendments

• Inclusion of condition requiring a compliance certificate under s306 of the Water Management Act 2000 (Condition C.2A)

- The requirement for a complaints management process in the Construction Management Plan and Operational Environmental Management Plan (C.12 and C.34)
- The requirement in the Landscape Management Plan that the vegetation buffer shall be a minimum 5 metres in width and include trees a minimum 4 metres in height (C.14).
- The requirement that the Landscape management Plan detail proposals for groundcover suitable for livestock grazing (C.14).
- The requirement for the Bushfire Emergency Plan to include emergency contact details (C.15)
- Clarification that, if an Aboriginal object is discovered, all work *likely to affect the site* is to cease and be secured (C.27).
- The requirement for the Demolition Management Plan to include:
  - Details of waste management during decommissioning
  - soil testing to be undertaken prior to the operation of the solar farm to provide a baseline for restoration during decommissioning (C.1).
- The Requirement for a management plan to monitor and, where identified mitigate significant glare impacts (C.34A)
- Deletion of Condition C.40 (replaced by C.34A)
- The requirement that the decommissioning plan is to be reviewed 12 months prior to implementation (C.38).
- The requirement for the reviews of the Operational Environmental Management Plan to be undertaken in consultation with the local Uranquinty community.
- Other minor amendments to clarify wording.

Council submitted revised recommended conditions of consent to the Panel on 21 December 2021 (**Appendix A**). The Panel has endorsed the revised conditions with the following amendments:

## Condition C.27

Replace the word "effect" with "affect" in the second line.

# Condition C.31

Insert the word "all" before the words "above and below ground infrastructure" in the second line.

## CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the panel considered written submissions made during public exhibition and heard from all those wishing to address the panel. The panel notes that issues of concern included:

- Construction traffic impacts
- Visual impacts
- Glint and glare Impacts
- Loss of agricultural land
- Fire risk
- Suitability of the site
- Waste and contamination associated with the development.

The panel considers that concerns raised by the community have been adequately addressed in the assessment report and that no new issues requiring assessment were raised during the public meeting. The panel notes that in addressing these issues the Panel has made amendments to the conditions of consent to strengthen the management and reporting of waste, potential glint and glare impacts, agricultural productivity and emergency management. The Panel is satisfied that the issues raised by the community are able to be managed through the Construction Management Plan, the Operational Environmental Management Plan and Decommissioning Plan
