- The Panel expressed concerns about the ability to defer the volume and nature of information requested to construction certificate stage and reinforced the need for the applicant to provide plans and supporting information about key outstanding issues to enable determination.
- The Panel requested the assessment planners discuss the information required directly with the applicant to ensure there is sufficient information to enable the determination of the matter.
- The Panel reinforced the need for it to be provided with all necessary relevant information, within the legislative framework, to enable determination of the matter.
