## **REASONS FOR DEFERRAL**

Whilst the Panel acknowledge there is merit in the proposal, they agreed to defer the determination of the matter to enable the resolution of fundamental issues in the assessment report and draft conditions, including the clarification of the development for which approval is sought, the identification of key issues and their mitigation through proposed conditions of consent. The Panel requested the DPE liaise with Council assessment staff to agree on a pathway and any support for the provision of the above information and to advise Panel of the steps required to enable the finalisation of an updated assessment report and condition set.

When this information has been received, the panel will determine the matter electronically. The Panel expects an addendum assessment report and updated condition set responding to the material and the matters raised above.

The Panel adjourned during the meeting to deliberate on the matter and formulate a resolution. The decision to defer the matter was unanimous.
