## **MATTER DEFERRED**

PPSSTH-89 - HILLTOPS - DA2021/0145 at LACHLAN VALLEY WAY BOOROWA 2586 – SOLAR ENERGY SYSTEM (5MW SOLAR FARM) (as described in Schedule 1)

## **REASONS FOR DEFERRAL**

The panel agreed to defer the determination of the matter for the following reason:

• The Panel requires specific advice from Council in accordance with Clause 66C(1)(a) of *State Environmental Planning Policy (Infrastructure) 2007* with respect to the potential safety risks or risks to the integrity of the APA gas pipeline in the vicinity of the development.

The following information is required to be submitted by Council to the Panel within 2 weeks of the date of this record:

- A plan clearly showing the location of APA gas pipeline and easement and its relationship to the proposed development.
- Advice by way of an assessment of the potential safety risks or risks to the integrity of the APA gas pipeline.
- The following amendments to the recommended conditions of consent:
  - Inclusion of condition requiring the preparation, approval and implementation of a Construction Environmental Management Plan (CEMP).
  - Inclusion of a condition requiring the preparation, approval and implementation of an Operation Environmental Management Plan (OEMP). The OEMP should specifically include measures to monitor glint and glare impacts, manage weeds on the site and on-going management of the landscape screen areas, including supplementary watering of plants to ensure establishment.
  - o Include a condition requiring submission of an amendment to Landscape Details Plan drawing number BOO1B—7300 indicating a tree buffer width of 4m and height of 3m.
  - Amend Condition 19 to require Meads Lane to be restored to the applicable Council road standard following construction and prior to operation of the development.
  - o Amend Condition 49 to referenced the amended Landscape Details Plan.
  - Amend Condition 60 to require that the decommissioning plan is to be reviewed 3 months prior to implementation, in consultation with Council.

When this information has been received, the panel will determine the matter electronically.

The decision to defer the matter was unanimous.
