Further to our discussions this afternoon, I can confirm that Subsidence Advisory NSW has been advised by the NSW Resources Regulator that mining will no longer occur under some parts of Wilton. The Wilton Public School is within that area.

The site currently has surface Development Guideline 6 but will soon be revised to Guideline 8-No restrictions.

You can proceed to design the school buildings assuming no mine subsidence design conditions will apply.

The entire area will for now remain in a declared Mine Subsidence District meaning that development applications must still be referred to us for approval, but with a G8 designation, the plans will be approved in the shortest possible timeframe.
