Development Application for Proposed ESQ 1818 Stage 4 & 5 Development, 18-22 Ransley Street and 123 Mulgoa Road, Penrith

Thankyou for your response yesterday as below and attached letter dated 8 December 2023 in the relation to the abovementioned Development Application.

The Sydney Western City Planning Panel (the Panel) held a determination briefing on the application yesterday and were advised of the NSW State Emergency Service (SES) referral received and copy provided.

The Panel has sought a position from Council and the applicant on this matter by 5pm today to inform their determination of the application.

I understand the applicant has made separate representation to you and that you have indicated that the advice provided may have misinterpreted Council's referral.

It is evident from the Brett Whitworth letter to Penrith City Council (MDPE21/1789) dated 17 July 2021 that: *increases the capacity of a development,* in relation to the: *capacity of evacuation routes,* may be open to interpretation.

In this regard, please find attached a copy of your advice to Council dated 13 October 2017 in relation to the proposed development then subject of a Planning Proposal.

This advice related to an assessment of the broader Masterplanned Panthers Precincts, including the ESQ1818 proposed development.

It found that these precincts can evacuate via the Mulgoa Road evacuation route to the M4 Motorway within the flood forecast timeframe, noting the route is nearing full capacity.

In view of this earlier advice, it is suggested in relation to the Brett Whitworth letter in assessing against clause 5.21 (2) (c) of Penrith Local Environmental Plan (LEP) 2010 to determine if an application exceeds the capacity of evacuation routes that in this particular circumstance the development has already been considered in detail under the Planning Proposal as being within the capacity of existing evacuation routes.

That is the current Development Application does not increase the capacity of the development. In fact the proposed development under the application represents a cumulative total with already approved and under construction stages 814 dwellings

which is a reduction in the 850 dwellings assessed and capped under the Planning Proposal, now reflected in the LEP provisions.

On this basis it is arguable if the proposed development is subject of the need be referred to Resilience and Urban Sustainability | Department of Planning and Environment, and the SES under the terms of the interim measure outlined in

the Brett Whitworth letter. Notwithstanding Council did refer the application, anticipating confirmation that the proposed density had already been accounted for as reflected in the Hawkesbury-Nepean Valley flood evacuation modelling to

inform flood risk management planning, Hawkesbury-Nepean Valley Flood Risk Management Strategy May 2023 where Table 3.2 refers to Penrith Panthers as Committed Residential Development.

It is therefore requested that you urgently re-consider your most recent advice in relation to the current development application such that Council can respond to the Panel which has requested a position from Council by 5pm today.

We have received a DA from Penrith City Council that we are required to refer to the NSW SES for your advice in regards to evacuation capacity.

The attached letter outlines an interim referral process for development applications Penrith, Hawkesbury and Blacktown councils that commenced in 2021 and is still operating.

Summary of the interim process:

• The process initiated assesses against clause 5.21(2)(c) to determine if the application exceeds the capacity of evacuation routes

- The Department is required to coordinate a response from the RA and NSW SES when:
 - 1. The development application increases capacity of development by more than 150 dwellings or 200 employee vehicles (for commercial), or
 - 2. Multiple development applications located close together could create the conditions of (1).
