The chair reviewed attendance and introduced the Kick Off Briefing purpose and process.

Applicant

- The applicant provided a description of the proposed development, the development site, relationship of development to the Landcom Masterplan and approved concept DA.
- The applicant outlined design measures incorporated to address DEP and Council comments to date.

Council

- Council noted inconsistency with the concept plan and advised that modification will likely be required to facilitate proposed development. Council's key issues include:
 - o Building separation, envelopes and through site links
 - Deep soil areas and dispersion across site
 - Discussion required with TfNSW regarding commuter carpark and road network design
- Council is preparing its RFI, but is awaiting comments from its Design Excellence Panel (DEP) comments prior to issuing it.

Panel

- The Chair advised that the Panel has undertaken a site visit for the site.
- The panel strencouraged expediting both the modification of the concept plan and discussions with TfNSW so that they did not hold up determination of the DA.
- The Panel would like a future briefing in approximately 4-5 weeks so it can monitor the progress of the assessment with the benefit of the DEP comments and the response to the RFI.

Note:

Council is yet to undertake its full application assessment, so this record is not a final list of the issues they will need to consider in order to draft their recommendation.

The application is yet to be considered by the Sydney Western City Planning Panel and therefore future comment will not be limited to the detail contained within.
