ISSUES LIST

Chair reviewed attendance and introduced Kick Off Briefing purpose and process.

Council

- Council's hold significant concerns with the multiple elements of the proposed development, including:
 - Access and driveway
 - o 8m setback not achieved
 - o Concerns for amenity impacts on internal users
 - o Potential for isolation of site to the east
 - o Non-compliance with deep soil area provisions
 - o Basement access non-compliant with BCA
 - Potential for site isolation

Council is preparing its formal RFI listing these issues.

- In summary, the proposed development on the subject site is considered inappropriate given matters listed above and Council is unlikely to be able to support the application in its current form. The application would require substantial redesign to gain Council's support.
- Notification period concluded two submissions received.

Applicant

- The applicant outlined the difference in the nature of the use of the site between a general residential land use and childcare centre.
- The applicant outlined their approach regarding setbacks, deep soil proposed and landscaping.

Chair

- The panel enquired as to whether there were changes possible that would be able to gain Council's support.
- The chair summarised Council's concerns for the applicant. The chair reiterated the importance of addressing a number of the threshold concerns of Council in order to allow for the application to progress.

Note:

Council is yet to undertake its full application assessment, so this record is not a final list of the issues they will need to consider in order to draft their recommendation.

The application is yet to be considered by the Sydney Western City Planning Panel and therefore future comment will not be limited to the detail contained within.
