- David and I inspected this site with Nabil and the assessing officer and were shown the location of the proposed road.
- We commented on the different reasons why the road across the site was required, and noted the condition of the vegetation to be removed and retained.
- At David's suggestion we drove down to look at the portion of the site adjoining the substation. It was
 agreed that the Council should explore whether the connecting road could be built there as it would avoid
 dividing the proposed recreation land. It appeared that the road could be constructed without unacceptable
 vegetation loss.
- Council advised that it would investigate.

The Chair has asked for the Secretariat to note that when he and David Kitto inspected the site for this DA with you on 20 May 2024, it was agreed that the Panel would be assisted by advice as to whether the proposed connecting road required by the TfNSW policy changes could feasibly be located adjacent to the substation as a means to avoid fragmenting the proposed public recreation area.
