#### MATTER DETERMINED

PPSSWC-326 – Penrith – MOD23/0058 – 1-21 Grady Crescent, Erskine Park - 4.55(2) Modification to an Approved Waste Management Facility (Tyre Recycling) to Increase Processing Capacity from 29,000t to 60,000t per year.

### PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at briefings and the matters listed at item 8 in Schedule 1.

#### **Modification application**

The panel determined to approve the modification application pursuant to section 4.55 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

## **REASONS FOR THE DECISION**

The panel determined to approve the application for the reasons outlined in the council assessment report, replicated as follows:

'The modified proposal has been assessed against the relevant environmental planning instruments and in this regard, the proposal is considered to satisfy the aims, objectives and provisions of these policies. The proposed modification is not considered likely to create any significant impacts on the natural, social or economic environments and in this regard, the application is considered to be in the public interest and recommended for approval.'

The panel also determined to approve the application in view of the matters addressed in council's supplementary assessment report, which addresses matters raised by the Panel in its Record of Deferral dated 1 December 2023.

At the Panel meeting on 27 November 2023, the Panel requested that further consideration be given to the adequacy of the existing and proposed fire safety measures due to the potential increase in fire risk resulting from the proposed modification to increase processing capacity.

The Panel has been briefed with a supplementary assessment report dated 8 December 2023 and additional information provided by the Applicant addressing these matters.

The Council and the Applicant have agreed the revisions to the conditions and Council has now prepared, at the Panel's request, revised conditions relating to fire safety. In particular, condition 6 has been revised to insert more specific fire safety obligations and a new condition 40 has been inserted requiring an updated Fire Risk Assessment. Proposed condition 3 was also deleted on the basis that the condition has already been complied with; proposed condition 4 was amended to address tyre storage matters; and a minor amendment was made to proposed condition 8 on the basis that the application is not for designated development.

## CONDITIONS

The modification application was approved subject to the conditions in the council assessment report and the council's supplementary assessment report.

#### CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the panel notes that no written submissions were made during public exhibition and therefore no issues of concern were raised.
