MATTER DEFERRED

PPSSWC-334 – Liverpool – DA-50/2021/A – 23 Charles Street, Liverpool - Modification of development consent under section 4.55 (2) of the Environmental Planning and Assessment Act 1979 to alter the approved building form including internal design changes.

REASONS FOR DEFERRAL

The Panel considered the matters listed at item 6, the material listed at item 7 and the material presented at the meetings observed at the site inspection listed at item 8 in Schedule 1.

Council staff advised that since its assessment report dated 8 August 2023 to the Panel recommending refusal of the DA was prepared, the Applicant has agreed to address Council's concerns about the modification application and associated documentation such that Council is now optimistic those criticisms will be resolved.

The Panel agreed to defer the determination of the matter until 18 September 2023. The matter was deferred to allow for the provision and assessment of all outstanding information.

The decision to defer the matter was Unanimous.

ACTIONS

To allow for the progression of the Modification Application to determination, the Panel recorded the Applicant's and the Council's agreement to the following timetable:

- 1. The Applicant shall supply all outstanding information to Council and upload all revised documentation to the Planning Portal by 5pm 1 September 2023.
- 2. Council is requested to provide a revised assessment report responding to the information and documentation so supplied, which is to be uploaded to the Planning Portal by 5pm 11 September 2023.
- 3. When the updated assessment report is received by the Panel, it expects to determine the application by way of electronic determination by or before 18 September 2023.

If the outstanding information is not provided by 11 September 2023 the Panel may move to determine the DA based on the information currently at hand.
