With the projection of a substantial surge in vehicular traffic, the deficiency of car spaces is a glaring concern that can't be dismissed. 5. Absence of a Social Impact Statement: The proposal, unfortunately, fails to address its social implications adequately or provides a comprehensive study of its likely impact on the immediate environment – a fundamental requirement for a project of this magnitude. 6. Public Awareness: The unconvincing nature of this proposal necessitates that the public be informed and made aware. I find the proposal sufficiently absurd that I find myself compelled to bring the matter to the attention of 'Current Affair,' for broader public scrutiny. The concerns raised above need thoughtful introspection and careful evaluation before any change is implemented that could sow the seeds of irreversible damage to our beloved community. The gravity of the matter calls for a revision in the DA 398/2023 proposal, and we hope and trust our concerns will receive the seriousness they warrant.

I am writing to express my strong objections to the proposed development application DA 398/2023 concerning the school-based childcare center. Traffic: The proposed location is already heavily congested with traffic, hence creating further on-street parking demand due to a new childcare center without considering feasible traffic solutions would exacerbate the current situation. Surplus Childcares: The community already has numerous existing childcare centers, many of which have open spots, making the need for yet another one redundant and insensitive to the current economic context. Insufficient Car Spaces: The present plan includes insufficient car spaces to accommodate the expected increase in vehicles (from the staff and parents). Lack of Social Impact Statement: There is no accompanying Social Impact Statement with this application. Asbestos Concerns: Given the age of the existing facilities, there might be a risk of asbestos, which could pose severe health risks during the construction phase. Therefore, a comprehensive asbestos review and management plan should be a prerequisite for approval. Environmental Sustainability and Waste: The documents provided fail to address how the proposal aligns with principles of environmental sustainability. There is a lack of a comprehensive waste management plan, and the potential for increased waste disposal from the facility should be adequately planned to avoid a significant environmental impact. In light of these objections, I respectfully urge the council to reconsider this development application. It seems apparent from the above points that the proposal does not consider the welfare of the residents or the environment. Thus, it seems neither socially nor environmentally responsible to proceed until adequate solutions to these concerns are provided. Thank you for your attention to this significant community issue.
