Chair reviewed attendance and introduced Preliminary Briefing purpose and process.

Applicant

- The applicant provided description of the proposed development and site context.
- The applicant discussed cross ventilation, building separation and setbacks proposed under the application.

Council

- Council advised they are currently undertaking a preliminary assessment of the proposed development.
- Council noted that traffic issues have been identified related to the design of the car park ramps.
- Council advised they are tentatively targeting determination of this matter for April 2024, with an earlier date possible if the issues are resolved sooner.

Panel

- The panel chair requested that a further briefing be held in February 2024 to obtain an update on the status of the assessment of the application.
- The panel targets determination of RSDAs within 250 days. The chair recommends that the applicant expedite their efforts to facilitate amendments or additional information required by Council to allow them to complete their assessment. The panel may determine development in the form it is presented at or prior to 250 days.

Note:

Council is yet to undertake its full application assessment, so this record is not a final list of the issues they will need to consider in order to draft their recommendation.

The application is yet to be considered by the Sydney Western City Planning Panel and therefore future comment will not be limited to the detail contained within.
