Chair reviewed attendance and introduced Preliminary Briefing purpose and process.

Applicant

 The applicant provided a description of the proposed development to include the construction of a new registered club premises and outdoor recreation facility in conjunction with existing golf course.

Council

- Application still on notification one (1) letter of support received in response to date.
- Internal and external referrals received.
- Matter has been to a design review panel.
- Request for information was sent to the applicant who is currently reviewing and providing a response.

Panel

- The panel queried what the response has been made to the Design Review Panel's suggestion that parking be provided underground. Council staff advised that the issues with parking identified by the DRP could be resolved with suitable landscape screening.
- The Council outlined it is anticipated to finalise the assessment of the application in the last week of August.
- The panel chair advised another briefing is unlikely and a final e-determination briefing could be arranged unless major issues arise.
- The panel targets determination of RSDAs within 250 days. The Chair recommends that the applicant expedite their efforts to facilitate amendments or additional information required by Council to allow them to complete their assessment.

Note:

Council is yet to undertake its full application assessment, so this record is not a final list of the issues they will need to consider in order to draft their recommendation.

The application is yet to be considered by the Sydney Western City Planning Panel and therefore future comment will not be limited to the detail contained within.
