## MATTER DETERMINED

# PPSWES-134 - DA 551/2021(1) - Orange

Lot 201 DP 1276846, Lot 1 DP 1286548 - 7 Murphy Lane and 415 Mitchell Highway, Orange, Educational establishment (demolition, new building and 750 students)

## PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters listed at item 8 in Schedule 1.

## **Development application**

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The Panel's decision was unanimous.

### **REASONS FOR DECISION**

The Panel determined to approve the application for the following reasons:

- The proposed development will reasonably satisfy Local and State planning controls.
- The proposed development will comply with the requirements of State approval authorities.
- Impacts of the proposed development on the natural and built environment will be within acceptable limits, subject to mitigation conditions.
- The proposed development will complement the existing or desired future character of the area.

#### CONDITIONS

The development application was approved subject to the conditions detailed in Council's Assessment Report with amendments as follows:

Ongoing operation of the Policy, Dot point 2 to read as follows -

"The Policy and ongoing monitoring is to be provided to parents, staff and children on a regular basis, and not fewer than monthly through the regular monthly electronic communication with parents."

Ongoing operation of the Policy, Dot point 3 to read as follows -

"Numbers of students travelling to school via private vehicle shall be monitored and accurate reporting provided to Orange City Council every 3 months from the operation of the development consent."

## CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the Panel considered 1 written submission received outside of the exhibition period. Issues included Neighbourhood context, height, bulk, scale and setback, Privacy, Noise and Light spill.

The Panel considers concerns raised in submission has been adequately addressed in the Assessment Report.
