MATTER DETERMINED

PPSWES-159 – Hay – 2022-10 - 32570 Sturt Highway, Hay - UAG Bio Nutrients Facility (as described in Schedule 1).

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

Development application

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The Panel determined to approve the application for the reasons outlined in the Council Assessment Report and was satisfied that the use and impacts could be appropriately regulated and mitigated through conditions of consent. The Panel noted the importance of the project and the potential social, economic and environmental benefit of the facility.

CONDITIONS

The Development Application was approved subject to the conditions in the Council Assessment Report with the following amendments.

- Condition (1) - **Compliance with Consent**, to be amended as follows:

The Development must:


- be carried out in accordance with the approved plans and recommendations and directions contained within UAG Bio Nutrients EIS (February 2022) & UAG Bio Nutrients EIS Supporting Documentation (October 2022), except where varied by conditions of this consent; and
- only input waste material originating from the subject site; and
- limit the processing of material to no more than 5,000 tonne per annum.

- Condition 16 - **Essential Energy Conditions** to be amended as follows:

A minimum distance of 15 metres from the nearest part of the development to Essential Energy’s infrastructure (measured horizontally) is required to ensure that there is no safety risk.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the Panel notes that no written submissions were made during public exhibition and therefore no issues of concern were raised.
