**Development Application No 2019/223 – Corowa Aquatic Centre  
Submission – Corowa Amateur Swimming & Lifesaving Club (Corowa Swimming Club)**

We refer to the above Development Application.

Whilst our Club is excited by the proposed new Aquatic Centre we have some concerns in relation to the size of the "Swim Club Room" referred to in the Application.

From the plan attached to the Application (Attachment C), the space allocated for the "Swim Club Rooms" is 5850 x 5950. **We submit that that space is not a sufficient space for the 'Swim Club Room'.**

#### **Submission 1**

The old Club Rooms included both a shower room and a kitchen (containing two ovens, a fridge, microwave, sink, bench space and overhead cabinets as well as a meeting space.

We had anticipated that the new Club Room would be of a sufficient space to again have a kitchen as well as an area for our members to meet and also to undertake dry land exercises. A space of less 5850x5950 would be insufficient for that purpose.

***It is our submission that the Swim Club Room should be of a size that will adequately allow a kitchen space (which would again include an oven, fridge, microwave, sink, bench and cabinets) as well as a meeting space for our members. We suggest that a more appropriate size for the Swim Club Room would be 5950 (assuming that this is as wide as the room can be) x 13850 (the size presently allowed for the plant room.)***

In addition, we do not appear to have been allocated a storage room for Swim Club equipment. In the past the Swim Club has been responsible for the storage of lane ropes and flags as well as other equipment used by our members. We had previously stored much of that equipment in the Club Rooms as well as in the shared storage room. This led to the inability to properly utilise the Club Rooms as a community meeting place. ***Is it intended that Swim Club utilise the proposed "Storage Room" for that purpose? If not, it is submitted that the plan should include a further lockable storage space for the Swim Club to utilise for the storage of Swim Club's equipment as well as the undercover storage of lane ropes and flags.***

Once again, we are excited for what the proposed Aquatic Centre will bring for both our Community and our Club and look forward to working with Council to bring the best possible outcomes for both our Community and our Members.
