PPSWES-229 - DA2024/040– CARRATHOOL 10738 KIDMAN WAY HILLSTON 2675 - 5MW Solar Farm (as described in Schedule 1).

Development application

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

REASONS FOR THE DECISION

The Panel determined to approve the application for the reasons outlined in the Council Assessment Report.

CONDITIONS

The Development Application was approved subject to the conditions in the Council Assessment Report with minor edits to Draft Conditions 3 and 59, together with the amendment of draft Condition 24 requiring the landscape plan to provide for landscape screen buffers as outlined on pp.28-29 of Moir Landscape Architecture's *Hillston Solar Farm Glint & Glare Assessment* report dated 07/05/24.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the Panel considered the written submission made during public exhibition. The Panel notes that issues of concern included:

- Access road amenity and maintenance
- Access road drainage

The Panel considers that concerns raised by the community have been adequately addressed in the Assessment Report. The Panel notes that in addressing these issues appropriate conditions have been imposed addressing the upgrade and maintenance of the access road surface quality.
