#### **KEY MATTERS DISCUSSED**

The Panel notes the applicant presentation and matters discussed with the applicant and council during the briefing. In particular, the Panel notes:

- RFI issued, response due 13 Feb
- A contribution will be conditioned in lieu of a shortfall of 20 parking spaces and formal acceptance of this by the applicant is to be provided to Council
- Public parking availability in the area
- 7 x agencies will utilise the building i.e. TfNSW, DPHI, Premiers, Education, DCS, Aboriginal Housing, Family & Community Services. Matter raised regarding suitability of security.
- Existing approval didn't proceed and downscaled version now proposed. Staff capacity will remain the same.
- Condition required re bins not to be left on public roadway after collection

#### **NEXT STEPS**

- Council to forward letter to applicant regarding proposed contribution amount
- RFI response pending
- Draft conditions expected within 2-3 weeks
- Possible determination by early March 2025
