## Further commentary on TfNSW advice: Gulgong Quarry Project

Reference is made to a query made by Garry Fielding, Western Regional Planning Panel, at 18 February 2025 video conference and briefing with the Western Regional Planning Panel regarding a TfNSW RFI request, namely:

"5....(d) Necessity for lighting at the remote location in accordance with AS1158.3:2020, "

Please refer to the email clarification received today from traffic consultant Craig Nethery of Streetwise Road Safety & Traffic Services Pty Ltd (attached). Streetwise advise that this Australian Standard only applies to lighting for pedestrian areas. No pedestrian areas are either existing or proposed at the intersection of the proposed internal quarry access route at or near the intersection with the Castlereagh Highway. In short, this Australian Standard is not applicable to this quarry project. A review of consents granted for various quarry projects with access to a classified road finds that none of the consents issued require public lighting at the intersection of the internal quarry access road and that classified road. A number of the approved quarries surveyed by Outline Planning Consultants have much larger rates of production and truck volumes than the Gulgong Quarry Project.

## Also of note, the most recent consent for a quarry issued by the Hunter and Central Coast Regional Planning Panel in July 2024 for a similar quarry (330,000 tonnes per annum extraction rate) only required a BAR/BAL intersection upgrade by the relevant office of TfNSW.

The accompanying Table 1 provides a summary of the quarries surveyed.

Further to our discussion this morning for the outstanding response to Item 5(d) of the TfNSW response to the Development Application for above.

For clarity the TfNSW comment reads as follows.

Following consideration of the above matters, should an alternative treatment be proposed (e.g. a Channelised Right-turn (CHR) treatment), amended strategic road designs should be submitted for consideration in accordance with Austroads Guides, Australian Standards and relevant TfNSW supplements and standards. The design is to consider:

d) Necessity for lighting at the remote location in accordance with AS1158.3:2020,

The above Australian Standard reference refers to the AS1158.3 being for Pedestrian area (Category P) lighting – Performance and design requirements.

The location of the proposed quarry is located on a classified road being the Castlereagh Highway. There are no existing pedestrian facilities along the road formation in the vicinity of the proposal. The proposal will not attract or require pedestrian access to and from the site so therefore there is no necessity to consider the design of Pedestrian Streetlighting in the vicinity of the proposal in this case.
