The Panel determined to approve the application for the reasons outlined in the Council Assessment Report.




CONDITIONS

39	<p>Hours of Operation</p> <p>Hours of operation of the Back O’ Bourke Exhibition Centre shall be between 9am and 5pm, Monday to Sunday with functions operating until 10pm.</p> <p>Note: Any variation to these hours will require Council consent via the lodgment of an application under Section 4.55 of the Environmental Planning and Assessment Act 1979.</p> <p>Condition reason: To ensure that the amenity of the surrounding area is not compromised as a result of the operation of the development.</p>
