MATTER DETERMINED

PPSWES-78 – Dubbo – DA21-211 at 47 R Wellington Road Dubbo for a solar farm (as described in Schedule 1)

PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

Development application

The panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The panel determined to approve the application for the reasons outlined in the council assessment report. In particular, the panel notes the following:

- The proposed development complies with all relevant provisions of the Dubbo LEP 2012;
- The proposed development complies with all relevant provisions of the Dubbo DCP 2013;
- The proposed 5 metre-wide landscape buffer has been well designed to visually screen and soften the proposal within its largely rural landscape;
- The plans and documents accompanying the DA have been well considered and prepared, assisting in the determination of the DA.

In reaching its decision the panel expressed its appreciation to Council officers for their comprehensive and professional assessment of the application.

CONDITIONS

The development application was approved subject to the conditions in the revised council assessment report dated 7 June 2021. This report references new conditions 37, 38 & 39, together with minor amendments to conditions 5, 10, 11, 29 & 32.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the panel considered the single written submission made during the public exhibition of the proposal. The panel notes that issues of concern included:

- Removal of trees
- Contamination of groundwater & Eulomogo Creek
- Vegetation buffer and ongoing maintenance

The panel considers that concerns raised in the submission have been adequately addressed in the assessment report.
