PPSWES-9 – Bland Shire Council - DA2020/0004 at 331 Wargin Road, Wyalong – Millers Metal Quarry (as described in Schedule 1)

PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

Development application

The panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

- The proposed development is permissible with consent in the RU1 Primary Production zone applying to the site under Bland LEP 2011.
- The proposed development is satisfactory having regard to the matters for consideration under s4.15 of the EP&A Act 1979. The adopted recommendations appropriately address the relevant environmental planning considerations arising from Council's assessment of the DA.

CONDITIONS

The development application was approved subject to the conditions in the council assessment report, with the following amendments:

- Deferred Development Consent Condition 1 has been imposed to ensure that the proposed Planning Agreement is executed prior the prior to the commencement of the proposed development.
- Condition 4 has been introduced to ensure that a Quarry Rehabilitation and Closure Plan has been prepared to Council's satisfaction prior to the commencement of the proposed cdevelopment.

In coming to its decision, the panel notes that no written submissions were made during public exhibition and therefore no issues of concern were raised.
