Kiama Council have submitted an LEP Housekeeping PP to Gateway Assessment (PP-2025-1047).

I have attached the PP, LEP maps, Council Report and Resolution.

The time frame for receiving the Gateway from the Department is approx. 2 weeks.

Part of the PP seeks to apply a minimum lot size of 40ha to a number of sites throughout the LGA that currently have 'no minimum lot size'.
