## Acknowledgement Letter - Planning Proposal for 245 Marion Street, Leichhardt

Your planning proposal for 245 Marion Street, Leichhardt was received by Council on **18 September 2019** and is under assessment by Council's Strategic Planning and Policy team.

As described to you prior to lodgement, Council offers a pre-planning proposal application service which is generally used at the beginning of the process to ensure all potential issues are addressed prior to lodgement of a planning proposal. It is noted that the pre planning proposal service has not been used.

### What happens next?

Council officers will assess the planning proposal and prepare a recommendation to Inner West Local Planning Panel and Council for consideration. Council will then resolve whether to support or not support the planning proposal for a Gateway Determination. You will be formally notified of Council's decision.

Department of Planning Infrastructure and Environment's (DPIE) 'A guide to preparing local environmental plans' and 'A guide to preparing planning proposals' set out information in relation to the process of a rezoning review. If the Council notifies the proponent that the planning proposal is not supported, or if you are dissatisfied with Council's decision, you can lodge a rezoning review with the Department of Planning Infrastructure and Environment.

## Fees and Charges

In accordance with Council's *Fees and Charges FY2019/20*, for all LEP and DCP amendments any additional costs and expenses incurred by Council in undertaking studies, peer reviews, referral to panels (Inner West Planning Panel and Architectural Excellence Panel) and other matters are to be paid at cost. Unfortunately due to time constraints, Council is unable to provide a cost breakdown prior to engagement of consultants that are used to undertake any peer reviews.

# RE: Decision not to proceed with the Planning Proposal for 245 Marion Street, Leichhardt
