ADVICE AND REASONS FOR THE RECOMMENDATION

The Panel reviewed the Departments' Justification Assessment Report, undertook a site visit and briefing meeting with the Council and Proponent representatives.

The Panel considers the Planning Proposal has strategic merit on the basis that it will allow for the growing need for aged care accommodation in the North District. The Panel also considers the Planning Proposal to have site specific merit as it is of an appropriate scale and massing for the locality, allows for a wider active street frontage, provides for the local amenities of a neighbourhood centre and does not have undue impacts on the adjacent properties.

The Panel suggests that a site specific Development Control Plan (DCP), or suggested amendments to the current DCP, be provided and exhibited at the same time as the Planning Proposal.
