At the meeting between you/John Franklin (Ecological Australia) with DPE and OEH on Monday we agreed that you would advise us by today if you and your client wanted more time to amend the additional info provide by ecological. I am mindful that you probably had to discuss this with your client. I have discussed with Deanne Frankel and we have decided to give you until COB Friday to indicate if you wish to amend the document and the amount of time you need.

As indicated at the meeting we cannot guarantee that the additional information provided by Ecological will be accepted by DPE, Council, OEH or NSWRFS when we initiate further consultation process on the additional information, and then complete our assessment.

You will also recall that we indicated that although the additional information deals with biodiversity issues, bush fire protection and environmental zones, Council had also objected to the proposal on the basis of servicing issues, particularly vehicular access to the site and that you may wish to discuss this further with Council to determine if they are willing to consider other options for the development of the site. If for example they cannot agree on a suitable access to the site any discussion of other options will be off the table.
