## Hi Graham

Similar to Council, OEH doesn't consider the No 3R Kavanagh St Jerrabomberra Supplementary planning information report would change our response of 22 July 2016.

The land meets the criteria for High Conservation Value (HCV) applied for strategic planning, subdivision into small residential sized lots is not considered the best use of the land.

The fact that the land was already zoned environmental since 1990s and as paper subdivision didn't have dwelling entitlement seems to be overlooked by the consultant.

The proposal being outside any adopted local settlement strategy identifying future residential areas.

While it is acknowledged that the residue lands are now proposed to be given to Council it would be up to Council if it willing to accept them as part of the Mt Jerrabomberra Reserve and it is noted no funding has been proposed for ongoing management of these areas.
