The decision was unanimous.

## **REASONS FOR THE DECISION**

- The Panel does not consider a blanket height of 26 metres and a floor space ratio of 2.5:1 across the whole site would provide an appropriate built form outcome in the context of the heritage conservation area to the south.
- The Panel has not been satisfied that the proposed height will provide the appropriate transition between the taller forms to the east and the village characteristics to the south and west.
- The Panel is of the opinion that there is opportunity for an increase in height and density confined to specific portions of the site. However, this would need to be carefully considered and special provisions or clauses inserted into the Local Environmental Plan and supported by a Development Control Plan. This would allow the site to provide a transition from the Mill Hill Hotel to the Rectory and the conservation area to the south in a considered way. Similarly the public benefits of an open space meeting place and affordable housing must be demonstrated.

By way of comment the Panel notes there is a current DA approval for the site and the applicant may wish to pursue a modification or submit a new DA with the benefit of the heritage provisions.
