I hear your frustration and it doesn't help that there has been staff changes. Parramatta is a very busy council at present. I can assure you that PDU has been looking into the case. I have spoken with Rob Cologna myself and he confirms information that has been previously provided, that at this stage Council is unwilling to consider FSR over 2:1. Council is clear that it would be premature to approve the density you are seeking at this time. Ellen is looking into the work that is being done by TfNSW and DPIE around traffic modelling to gain an insight into the longer term picture for the precinct. Council advise that they will be providing advice to Councillors on planning proposals in Westmead in due course (not yet scheduled) and it would not be appropriate to meet with you until after this. In any case they are firm that they have given you a clear answer - even if it is not the answer you are seeking and so a further meeting is not necessary.

The Planning Delivery Unit was not established to change decisions made by local government. Our task is to remove any blockages. In this case there is not a blockage – Council has given clear advice, albeit disappointing from your client's perspective. I hope that we have at least provided clarity.
