Thanks for your email.

As mentioned in my previous email, it would be beneficial and time effective if TfNSW, Council (will include our senior traffic engineer as well) and WSP can be present in the meeting where the TfNSW feedback is discussed. We can thereafter discuss the WSP issues (which included traffic/transport related issues as well) and the TfNSW staff may leave the meeting after these issues are discussed.

Please let me know if you would like me to assist in coordinating a meeting with all the mentioned stakeholders.

The Planning Proposal is not at a stage to be presented to the Councillors in February 2022. In relation to the Councillor Briefing, it is advised that:

- The Direction issued by the Minister for Planning under Section 9.1 of the *Environmental Planning and Assessment Act 1979* and the charter of the Georges River Local Planning Panel 2018; both specify that the Planning Proposal is to be referred to the LPP for a recommendation before it is forwarded to a Council Meeting for a decision on whether or not to seek a Gateway Determination from the Department of Planning, Industry and Environment.
- Clause 7.6e of the Council's Code of Conduct does not permit the briefing of any planning proposal to the Council that is either before the Georges River LPP or that will come before the LPP at some future time, except during a LPP meeting where the application forms part of the agenda and the councillor has a right to be heard by the LPP at the meeting.

In light of the above, the Planning Proposals will not come before Councillors prior to them being considered by the LPP.
