## PANEL CONSIDERATION AND RECOMMENDATION

The Panel considered: the material listed at item 4 and the matters raised and/or observed at meetings and site inspections listed at item 5 in Schedule 1.

Based on this review, the Panel recommends that:

The decision was unanimous.

## ADVICE AND REASONS FOR THE RECOMMENDATION

The Panel believes that the site has potential for higher density and height, however the Panel is not convinced of the merits of the preferred option advocated by the proponent.

The Panel does not support the proponent's preferred option to develop to a maximum FSR of 2.8:1 and a maximum height of up to 57m, because of potential for adverse impacts on the residential areas in the vicinity and the existing limited capacity of the local road network. The Panel believes that this site should provide a more graduated transition from the high density Carlingford core to the lower density surrounding the site. Insufficient justification has been provided for the height and FSR, and the strategic basis for the density proposed has not been provided. It is noted that the Draft District Plan requires precinct studies on these strategic transport oriented development corridors such as occurs here.

In these circumstances, the Panel presently supports a smaller form of redevelopment as discussed in the Department of Planning and Environment report of 1.5:1 FSR with a height of up to 8 storeys (28m) and the provision of appropriate transition from the low density residential to the commercial core.

The Panel notes that there is an opportunity for the Gateway Determination to be altered if it were to be justified by a careful analysis of the urban design, height outcomes and traffic issues associated with any revised proposal.
