Hi Alex,

Further to Bill's email below advising that he had engaged a consultant ecologist to assist in responding to the correspondence Council received from BCD in relation to the Broken Head Quarry Planning Proposal, I wanted to provide you with an update on the status of these investigation and the corresponding likely timeframes.

As you are aware the North Coast Regional Plan (NCRP) has necessarily been prepared at a regional scale and without the benefit of site-specific ecological data. Therefore, the decision was made to commission detailed ecological investigations of the Broken Head Quarry site so that a deeper understanding could be achieved regarding any of the biodiversity values that the site may contain.

This will include a detailed assessment of vegetation integrity (condition) which will be achieved using the approach adopted in the NSW Biodiversity Assessment Method (BAM). The BAM determines the integrity of native vegetation (a score out of 100). A Biodiversity Development Assessment Report (BDAR) will be prepared by an accredited assessor that identifies the measures proposed to be utilised to avoid, minimise and offset the residual impacts of the proposed development.

This work is being undertaken by Adam McArthur who is a Director at JWA Pty Ltd as Adam is an accredited assessor to apply the Biodiversity Assessment Methodology (BAM) in accordance with the requirements of the NSW Biodiversity Conservation Regulation 2017 (Certification No.: BAAS18069).

Section 6.12 of the Biodiversity Conservation Act 2016 (BC Act) requires that a BDAR:

- "assesses in accordance with the biodiversity assessment method the biodiversity values of the land"; and
- "sets out the measures that the proponent of the proposed development ... proposes to take to avoid or minimise the impact of the proposed development".

The Act clearly provides for a 'mitigation hierarchy', commencing with avoidance. Similarly, the BAM (2020) expresses the expectation that avoidance must be demonstrated before minimisation or mitigation of impacts. Examples of avoidance and minimising impacts are provided in Section 7.1.2 of the BAM and include locating the development:

- in areas that have no biodiversity values; and/or
- in areas where the native vegetation or threatened species habitat is in the poorest condition (i.e. areas with the lowest vegetation integrity scores).

Targeted threatened species surveys will be undertaken on site during October to December as the vast majority of threatened species that are known to exist in the region will be able to be recorded during these warmer months.

We are aiming to have a final report to provide to Council early in the New Year. The timing will be finalised once we know the results of the field surveys as there may be a need to undertake further survey work depending on outcomes of the survey work.
