## TERMS AND CONDITIONS

Any eData provided or made accessible by Gray Puksand Pty Ltd ("Gray Puksand") for the Project is for the sole purpose of use strictly in accordance with these Terms and the express written terms and conditions of any architectural consultancy services agreement or copyright license ("Agreement") entered or granted by Gray Puksand with its client for the Project ("Client").

### EData Disclaimer – Use of Models, Files and Drawings

By opening any edata model file or files ("File") provided to you by Gray Puksand you the user ("User") agree to the following: The File is provided by Gray Puksand to you the user (individually, a "User", or collectively, "Users") and is subject to the terms and conditions stated below as Terms of Use.

The User acknowledges that the requirements of these Terms of Use apply to all of User's principals, employees, and agents.

The User acknowledges that Gray Puksand to the extent permitted by law, all conditions and warranties concerning any eData and any information, designs, documents or data within any eData or any use to which any of them may be put (whether as to quality, outcome, fitness, care, skill or otherwise) whether express or implied by statute, common law, equity, trade, custom or usage or otherwise are expressly excluded and Gray Puksand liability for breach of any warranty or express or implied condition, to the extent permitted by law, will be limited, at the option of Gray Puksand to the replacement or repair of the eData or the payment of the cost of replacing or repairing the eData.

The File is made available to User solely as a convenience to the User and for informational purposes only.

The User releases and indemnifies and will keep indemnified Gray Puksand against all claims, liabilities, loss, costs and expenses arising directly or indirectly out of or in connection with the provision to the User of, or any use, reliance upon, reproduction or disclosure of or change to, the eData by the User or any other person accessing the eData (whether directly or indirectly) through the User.

The User acknowledges and agrees:

- that the use of the File is not a substitute for professional judgement.
- the File was developed as an input to assist the preparation of drawings which Gray Puksand are contracted to provide.
- that the use of the File does not relieve the User from applying the appropriate standard of care and skill relevant to the use of the File and its contents
- that the File is only to be used as a tool to assist the User in connection with the Project
- that the User is solely responsible for verifying the accuracy of all results created with the use of the File
- Gray Puksand are not responsible or liable for the means and methods of construction and the User's use of the File shall in no way give rise to such responsibility or liability by Gray Puksand
- The Consultant (and any other recipient of any File or Files) is alone responsible to check, verify, and otherwise confirm the accuracy and completeness of data contained in any File; and
- Confirming all dimensions on site and using data for measurement is carried out at the User's risk and that of any other user.

Any permitted change in any eData must be made in a way to clearly distinguish those changes from the original eData and any permitted reproduction of the eData must also reproduce these conditions, Gray Puksand name as author and owner of copyright in the eData and the date of creation by Gray Puksand of the eData.

1. Subject only to the terms of the Agreement:
  - a. Gray Puksand retains ownership of all eData and of all intellectual property and related rights in or relating to any eData including without limitation all inventions, discoveries and designs, copyright, confidential information, know-how and trade secrets and all other rights conferred by statute, common law or equity in or in relation to the results of intellectual activity in the industrial, commercial, scientific, literary or artistic fields; and
  - b. No eData may be changed, used, copied, reproduced, provided or disclosed by or to any other person or for any other purpose without the written consent of Gray Puksand.
2. Each User is responsible for:
  - a. ensuring that the export format is satisfactory for its purposes and that the system on to which the eData is to be transferred is in good working order and able to properly accept the eData transfer.
  - b. maintaining the integrity of the eData.
  - c. checking and ensuring that the eData is the latest or most relevant version provided by or available from Gray Puksand.
  - d. carrying out all relevant investigations and examining and acquainting themselves and obtaining all necessary professional advice enough to allow them to properly form their own opinion as to the correctness, adequacy and sufficiency of the eData and its contents for the uses which their purposes and the uses they make of the eData;
