The "No More Its The Law" and four (4) house policy posters developed by the Liquor Industry Consultative Council (available from the Department of Gaming and Racing) must be prominently displayed throughout the premises.

In addition to any other notice required to be displayed there is to be prominently displayed in the premises, the "Intoxication" sign and at each public entrance way to the premises the "Proof of Age" poster (available from the Department of Gaming and Racing).

The Liquor Industry Code of Practice for the Responsible Promotion of Alcohol Products (available from the Department of Gaming and Racing) must be adopted in respect of the premises. A copy of the code must be displayed in a position in the premises where it will be readily available to and noticed by all staff involved in the sale and supply of liquor.

Low alcohol beer and non-alcoholic beverages must be available at all times when full strength liquor is available. The pricing structure of low alcohol beverages is to reflect the lower wholesale cost of those beverages.

Food must be available whenever liquor is consumed on the licensed premises.

The secretary is to maintain a register which is to contain a copy of the certificate of the satisfactory completion of the Responsible Service of Alcohol course by the secretary and for employees who have completed the course. The register is to be made available for inspection on request by a police officer or special inspector.

The secretary must as a minimum continually apply the house policies and practices on harm minimisation and responsible service of alcohol tendered to the Court at the time the application was granted. A copy of the house policy is to be maintained in the register in which the certificates of completion of the responsible service of alcohol course are filed. The house policy must be continually updated by additions that do not diminish from the issues approved by the Court and reflect legislative requirements, court,
