The registered club is to ensure that not less than one (1) supervisor for each one hundred (100) minors or part thereof, such supervisors being persons not less than twenty one (21) years of age, are engaged or assigned by the registered club for the purpose of supervising the conduct of minors whilst they are attending the function.

2) At least thirty (30) minutes before the commencement of the function and for not less than thirty (30) minutes after the conclusion of the function the persons required to be engaged or assigned pursuant to the above condition must patrol the exterior environs of the licensed premises to ensure the safe conduct of persons attending the function and that such persons do not disturb the quiet and good order of the neighbourhood.

(Imposed on 02 JAN 1998)

- 3) HARM MINIMISATION CONDITIONS IMPOSED ON 02 JUN 2000: The secretary shall take all reasonable steps to prohibit or restrict activities (such as promotions or discounting) that could encourage misuse or abuse of liquor (such as binge drinking or excessive consumption).
- 4) The secretary is to maintain a register which is to contain a copy of the certificate of the satisfactory completion of the Responsible Service of Alcohol course by the secretary and for employees who have completed the course. The register is to be made available for inspection on request by a police officer or special inspector.
- 5) The secretary must as a minimum continually apply the house policies and practices on harm minimisation and responsible service of alcohol tendered to the Court at the time the application was granted. A copy of the house policy is to be maintained in the register in which the certificates of completion of the responsible service of alcohol course are filed. The house policy must be continually updated by additions that do not diminish from the issues approved by the Court and reflect legislative requirements, court, industry and Department of Gaming and Racing recommendations.
- 6) The "No More Its The Law" and four (4) house policy posters developed by the Liquor Industry Consultative Council (available from the Department of Gaming and Racing) must be prominently displayed throughout the premises.
- 7) In addition to any other notice required to be displayed there is to be prominently displayed in the premises, the "Intoxication" sign and at each public entrance way to the premises the "Proof of Age" poster (available from the Department of Gaming and Racing).
- 8) The Liquor Industry Code of Practice for the Responsible Promotion of Alcohol Products (available from the Department of Gaming and Racing) must be adopted in respect
