Our family strongly object to the proposed plans submitted by Bradcorp. To allow	Confidential
Bradcorp's developement traffic to channel through Bingara Gorge will have a	
significant detrimental impact on the area. First and foremost the safety of the large	
number of small children in the estate will be put at risk. A large number of children	
use the main roads traveling by scooters or bicycles and the heavy vehicles will	
follow the same main routes. These routes have a number of round abouts and	
pedestrian crossings are not regulated by lights. The additional traffic and	
associated noise will have a very negative impact to our way of live since we are	
very close to Fairways drive and the proposed off ramp.

I do not agree with above proposal and feel it will significantly impact on our	Confidential
neighbourhood which have prodiminately families with young children and school	
age children accessing these roads. The roads are not designed for heavy traffic and	
could potentially put children's lives at risk.	
I understand that part of this proposal involves using small, narrow residential	Confidential
streets in Bingara Gorge as a main thoroughfare to the new development. The road	
was not constructed for this purpose, the proximity to housing very close and the	
roads and streets are simply NOT meant to take the volume or size of the traffic and	
trucks that would require access to the new development during the construction	
phase.	
The development should properly invest in proper roads from the onset to provide	
access to the new development for all vehicular traffic, in particular large	
construction vehicles rather than use the small residential streets which poses	
significant access and safety and inconvenience and noise concerns and impacts	
for local residents.	
We vehemently oppose any attempt to bring that volume of traffic through the	
residential streets of Wilton. This is simply unacceptable and this development	
should not be supported until a proper alternative access road is built.
