Draft Planning Agreement

Introduction

The purpose of this explanatory note is to provide a plain English summary to support the notification of the draft planning agreement (the **Planning Agreement**) prepared under Subdivision 2 of Division 7.1 of Part 7 of the *Environmental Planning and Assessment Act* 1979 (the **Act**).

This explanatory note has been prepared jointly by the parties as required by clause 25E of the *Environmental Planning and Assessment Regulation* 2000 (the **Regulation**).

Parties to the Planning Agreement

The parties to the Planning Agreement are the Minister for Planning ABN 38 755 709 681 (the **Minister**) and:

- Lochinvar Ridge Estate Pty Limited (ACN 623 520 016),
- Airds Pty Ltd (ACN 001 385 146),
- Edwin James Aird Junior of 801 New England Highway, Lochinvar NSW 2321
- Carol Ann Aird of 801 New England Highway, Lochinvar NSW 2321

(together the **Developer**).

Description of the Subject Land

The Planning Agreement applies to:

- Part of Lot 1 of Deposited Plan 718712 as shown hatched in Annexure A to the Planning Agreement
- Lot 2 of Deposited Plan 718712
- Part of Lot 32 of Deposited Plan 1132263 as shown hatched in Annexure A to the Planning Agreement

(together the **Subject Land**).

The Subject Land is located at 801, 803 and 805 New England Highway, Lochinvar NSW 2321.

Description of the Proposed Development

The Developer is seeking to subdivide the Subject Land into approximately 146 lots, creating 144 residential lots, one lot containing the existing dwelling currently located on Lot 2 DP 718712 and one lot containing the Aird's of Lochinvar commercial building, generally in accordance with the plan of subdivision at schedule 7 to the Planning Agreement and with DA 17-1401, which has been lodged with Maitland City Council (**Proposed Development**).

The Developer has made an offer to the Minister to enter into the Planning Agreement in connection with the Proposed Development.

Summary of Objectives, Nature and Effect of the Planning Agreement

The Planning Agreement provides that the Developer will make a monetary contribution of \$82,103 per hectare of net developable area (subject to indexation in accordance with the Planning Agreement) for the purposes of the provision of designated State public infrastructure within the meaning of clause 6.1 of the *Maitland Local Environment Plan 2011 (LEP)*.

The monetary contribution will be payable prior to subdivision certificates being issued in accordance with Schedule 4 to the Planning Agreement.

The Developer is required to provide a bank guarantee for \$20,000 on execution of the agreement and to register the Planning Agreement on the title to the Subject Land in accordance with section 7.6 of the Act.

The objective of the Planning Agreement is to facilitate the delivery of the Developer's contributions towards the provision of infrastructure, facilities and services referred to in clause 6.1 of the LEP.

No relevant capital works program by the Minister is associated with the Planning Agreement.

Assessment of Merits of Planning Agreement

The Planning Purpose of the Planning Agreement

In accordance with section 7.4 (2) of the Act, the Planning Agreement has the following public purpose:

- the provision of (or the recoupment of the cost of providing) transport or other infrastructure relating to land.

The Minister and the Developer have assessed the Planning Agreement and both hold the view that the provisions of the Planning Agreement provide a reasonable means of achieving the public purpose set out above. This is because it will ensure that the Developer makes appropriate contributions towards the provision of infrastructure, facilities and services referred to in clause 6.1 of the LEP.

How the Planning Agreement Promotes the Public Interest

The Planning Agreement promotes the public interest by ensuring that an appropriate contribution is made towards the provision of infrastructure, facilities and services to satisfy needs that arise from development of the Subject Land.

How the Planning Agreement Promotes the Objects of the Act

The Planning Agreement promotes the objects of the Act by encouraging:

- the promotion and co-ordination of the orderly and economic use and development of land.

The Planning Agreement promotes the objects of the Act set out above by requiring the Developer to make a contribution towards the provision of infrastructure, facilities and services referred to in clause 6.1 of the LEP.

The Developer's offer to contribute towards the provision of State infrastructure will have a positive public impact as funds from the Developer will be available towards the provision of infrastructure, facilities and services referred to in clause 6.1 of the LEP.

Requirements relating to Construction, Occupation and Subdivision Certificates

The Planning Agreement does not specify requirements that must be complied with prior to the issue of a construction certificate or an occupation certificate.

The Planning Agreement requires each instalment of the Development Contribution to be paid prior to the issue of the relevant subdivision certificate and therefore contains a restriction on the issue of a subdivision certificate within the meaning of section 6.15 of the Act.
